




- 1- R.G. Memorial Daksh Educational And Social Welfare Society, Dahariya Haldwani Dist Nainital is a Registered Society under the section 8.

1. Certified that the school shall provide information's in the DISE format every year, information and records of the school pertinent to the implementation of this Act as may be required by the Chief Education Officer/Authorized officer from time to time.
2. The school shall appoint teachers as per provisions of Section-23 of RTE Act 2009, the teachers who are appointed before the commencement of the Act and they do not possess minimum qualification as per Act, they shall attain minimum qualification by March 2015.
